The impact of which is evaluated by class teachers, the SENCo and the Headteacher.</li> <li>• When a pupil is not making expected progress in a particular area of learning the school can identify the need for additional support. This will then be discussed with parents/carers and, where appropriate, the pupil concerned. The SENCo will guide this process to ensure that there is always a clear focus for interventions.</li> <li>• Our staff are vigilant at supporting and raising any concerns. We use data and other forms of assessment to identify additional needs. Staff use the, assess, plan, do, review cycle in planning provision for SEND pupils.</li> <li>• If parents/carers have concerns about the progress or attainment of their child, they should, in the first instance make an appointment to speak to the class teacher to discuss their concerns. If there are still concerns after this, they should make an appointment to see the SENCo.</li> </ul>
<p>2</p>	<p><b>How will the Early Years school staff support my child/young person?</b> (Schedule 1: Points 2 and 3c, d, e)</p>	<p>We are a mainstream, inclusive school that fully complies with the requirements outlined in the Special Educational Needs Code of Practice (2014).</p> <ul style="list-style-type: none"> <li>• Best endeavours are made to ensure our practices comply with the Equality Act (2010).</li> <li>• We adopt a graduated approach to meet the needs of our learners.</li> <li>• Through Quality First Teaching our staff include all children, not just those with SEND.</li> <li>• We take a holistic school approach to supporting learners through our strong pastoral care systems.</li> <li>• When the school identifies the need for additional support, intervention is put in place to support the pupil.</li> <li>• Interventions may include working in small groups with adult support or working one to one in a specific area of learning.</li> <li>• We monitor the impact of interventions through observations, meetings and by tracking the children's progress.</li> </ul>

		<ul style="list-style-type: none"> <li>• Our SENCo leads on interventions, ensuring that there is a clear focus and the Headteacher supports the evaluation process and shares this information with Governors.</li> </ul>
3	<p><b>How will the curriculum be matched to my child's/young person's needs?</b> (Schedule 1: Point 3a, b)</p>	<ul style="list-style-type: none"> <li>• Teachers differentiate to meet the needs of pupils by looking at the next steps in their learning.</li> <li>• Teachers also consider the pupils' learning styles and will aim to deliver lessons that can be easily accessed by all.</li> <li>• Monitoring takes place to ensure all children have access to the curriculum which takes place both in the classroom and outside in the grounds.</li> <li>• Outside agencies are consulted when more specific adaptations are required. Referrals made by the Senco.</li> </ul>
4	<p><b>How will both you and I know how my child/young person is doing and how will you help me to support my child's/young person's learning?</b> (Schedule 1: Point 7)</p>	<ul style="list-style-type: none"> <li>• Parents/carers are invited to an Individual Learning Plan (ILP) meeting, three times each year, to discuss the support that the school is providing and how they can help their child at home.</li> <li>• At this meeting staff will talk about the progress your child is making and how their attainment looks in relation to age related expectations. We will also share ideas about how we can work together to help them to do even better.</li> <li>• Should more regular contact be required, our staff will make suitable arrangements to ensure this is put in place.</li> <li>• Annual reports are sent home at the end of each academic year, interim reports are sent home in the autumn term.</li> <li>• Generic updates on the curriculum are shared through our newsletter and/or website.</li> </ul>
5	<p><b>What support will there be for my child's/young person's overall wellbeing?</b> (Schedule 1: Point 3g)</p>	<p>Support is available for improving the emotional, mental and social development of all pupils through a range of strategies:</p> <ul style="list-style-type: none"> <li>• All our staff provide a high standard of pastoral support.</li> <li>• All pupils with an Individual Learning Plan (ILP) to ensure all adults working in the classroom environment are best able to meet the pupil's learning needs.</li> <li>• All of staff are paediatric first aid trained.</li> <li>• We have a medical policy in place and, where appropriate, staff administer medicines in agreement with parents.</li> <li>• Where there are specific medical needs, a small team of staff, who work most closely with the pupil, will access more specialised training to ensure that we are able to keep the child safe.</li> <li>• Our Behaviour Policy, which includes guidance on expectations, rewards and sanctions, is fully understood and in place by all staff.</li> <li>• We regularly monitor attendance and take the necessary actions to prevent prolonged unauthorised absence.</li> <li>• Pupils have the opportunity to voice their opinions through School Council, Eco council and PSHCE lessons, etc.</li> <li>• Some children have a named adult they can go to when needed.</li> <li>• Where appropriate, concerns are shared with relevant staff and confidentiality is adhered to at all times.</li> <li>• All staff are made aware of pupils' individual needs and ensure relevant information is accessible to all pupils.</li> </ul>
6	<p><b>What specialist services and expertise are available at or accessed by the setting/ school/ college?</b> (Schedule 1: Points 5 and 10)</p>	<ul style="list-style-type: none"> <li>• Our staff receive training and our teachers all hold qualified teacher status.</li> <li>• We have a number of established relationships with professionals in health, social care and other outside agencies.</li> <li>• We are part of a local partnership of schools and work together to access support from outside agencies.</li> <li>• All external partners we work with are vetted in terms of safeguarding.</li> </ul>

7	<p><b>What training are the staff supporting children and young people with SEND had or are having?</b> (Schedule 1: Point 5)</p>	<ul style="list-style-type: none"> <li>• Our SENCo attends appropriate courses and conferences to keep abreast of changes within SEND. This is then disseminated to staff.</li> <li>• Our SENCo regularly attends the West Horsham Schools' SENCo Network Meetings in order to keep up to date with local and national updates in SEND.</li> <li>• Our qualified SENCo holds the PGCiPP: National Award for Special Educational Needs Coordination.</li> <li>• Staff receive a variety of training opportunities.</li> <li>• Staff receive appropriate training to support pupils with medical needs</li> </ul>
8	<p><b>How will my child/young person be included in activities outside the classroom including school trips?</b> (Schedule 1: Point 3f)</p>	<ul style="list-style-type: none"> <li>• We are an inclusive school and promote the involvement of all our learners in all aspects of the curriculum including activities outside the classroom.</li> <li>• Where there are concerns of safety and access, further thought and consideration is put in place to ensure needs are met; where applicable parents/carers are consulted and involved in planning.</li> <li>• Best endeavours are made so that all learners can join in with activities regardless of their needs.</li> </ul>
9	<p><b>How accessible is the setting/school/college environment?</b> (Schedule 1: Point 6)</p>	<ul style="list-style-type: none"> <li>• We have an Accessibility Plan in place and is available on the school website. Also, available on the school website. Our policy and practice adheres to the Equality Act 2010.</li> <li>• We are vigilant about making best endeavours, where possible.</li> <li>• For school admissions, please visit 'Admissions' on the school website.</li> </ul>
10	<p><b>How will the setting/school/college prepare and support my child/young person to join the setting/school/college, transfer to a new setting/school/college or the next stage of education and life</b> (Schedule 1: Point 12)</p>	<ul style="list-style-type: none"> <li>• EYFS staff and Senco visit pre-school settings for all pupils new to the school during summer term.</li> <li>• For pupils with known Special Educational needs, the SENCo will visit the pre-school/previous school setting, where possible, in advance of admission to St John's.</li> <li>• We have very good relationships with the local secondary schools that our children move onto with transitioning school staff visiting to discuss all pupils, where specific pupil needs are shared.</li> <li>• Personalised transition support is provided for pupils transferring to an alternative setting.</li> </ul>
11	<p><b>How are the setting's/school's/college's resources allocated and matched to children's/young people's special educational needs?</b> (Schedule 1: Points 3e and 6)</p>	<ul style="list-style-type: none"> <li>• The Senior Leadership Team, which includes the SENCo, monitor provision through learning walks, talking to children, data analysis and scrutiny of books.</li> <li>• Budgets are closely monitored and aligned to the School Development Plan (SDP).</li> <li>• Pupils with an EHCP receive support as specified in their plan.</li> <li>• Pupils with additional needs are supported where it is essential in order to ensure quality learning for them and for others.</li> <li>• This additional support is monitored and adjusted carefully, so that the benefits are maximised.</li> <li>• The SEND Governor meets at least termly with the SENCo and feeds back to the full board so they are able to make informed decisions regarding resources allocated to the school to meet the needs of SEND pupils.</li> </ul>

12	<p><b>How is the decision made about what type and how much support my child/ young person will receive?</b> (Schedule 1: Point 8)</p>	<ul style="list-style-type: none"> <li>• Working with the child, their families and other staff, the SENCo considers a variety of options for suitable provision before deciding on a course of action.</li> <li>• Interventions are monitored and evaluated. Outcomes are defined at the start of any intervention.</li> <li>• The SENCo oversees additional support with the Headteacher.</li> <li>• External services also offer advice and support where needed.</li> </ul>
13	<p><b>How are parents involved in the setting/ School /college? How can I be involved?</b> (Schedule 1: Point 7)</p>	<ul style="list-style-type: none"> <li>• We whole-heartedly believe in partnering parents in a two-way dialogue to support a pupil's learning, needs and aspirations.</li> <li>• We operate an open door policy.</li> <li>• We take every opportunity to strengthen this dialogue.</li> <li>• Parents are involved in many volunteer roles within the school and there is a thriving and pro-active Friend's Association (PTA)</li> <li>• Our Governing Body includes Parent Governors/representatives.</li> </ul>
